

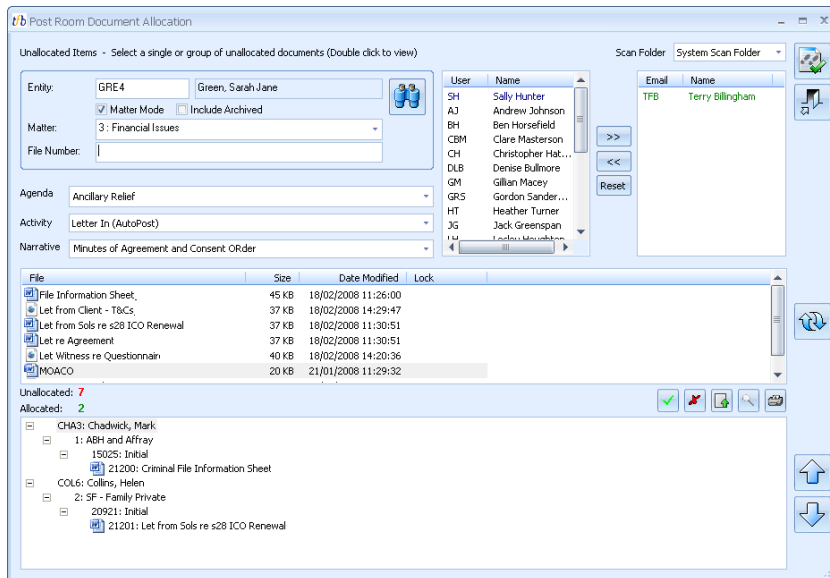
# DOCUMENT SCANNING/ALLOCATION

Use Partner for Windows Postroom Partner to import paper-based information into Partner for Windows Case Manager

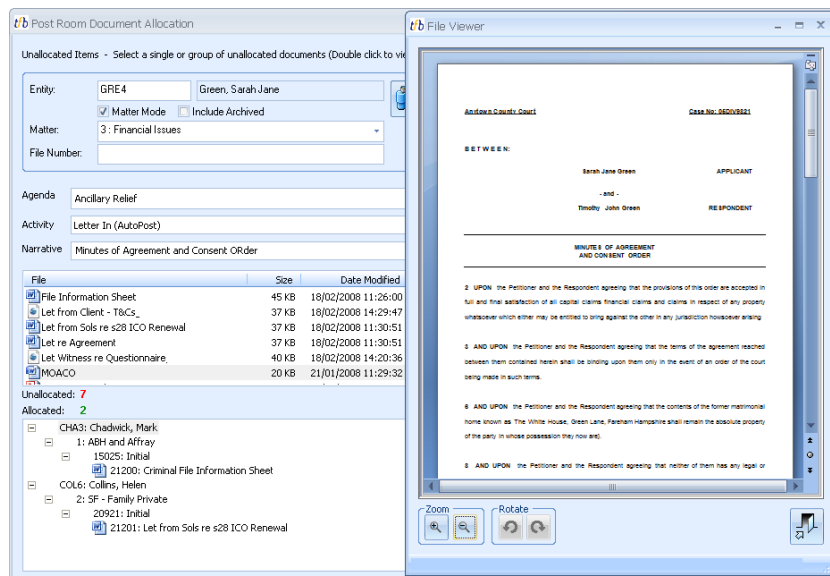
Using Postroom Partner to either scan or allocate, it is now possible for a user to:
